The AFP CA, Yosemite Chapter (formerly NSFRE), Employment Identification Number (EIN) 91-1870420, has been submitted to the Internal Revenue Service as an affiliate, participating in AFP's 501(c)(3) Group Exemption, Group Exemption Number (GEN) #3237.

Please verify that the EIN # shown above is the same as in your current records and on your bank and/or investment accounts.

The chapter is authorized to use this number for exemption purposes providing it complies with AFP's Annual Accord Policy. The chapter must be in Accord every year so that AFP can maintain the chapter's exempt status through our annual filing with the IRS. As a part of the Accord requirements, chapters with annual revenue in excess of \$25,000 must file a Form 990 or 990 EZ with the IRS every year.

The IRS requests that you include both the Group Exemption Number (GEN) and the chapter's EIN # on all tax filings and correspondence from the chapter.

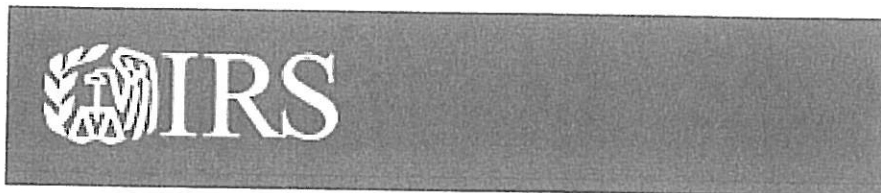
Based on the information supplied, we recognized the subordinates named on the list you submitted as exempt from Federal income tax under section 501(c)(3) of the Code.
